



REPAIR AFFAIR INFORMATION

Thank you for your interest in Repair Affair, a volunteer-based program dedicated to helping low-income elderly and disabled homeowners with essential home repairs. Please know that assistance is not guaranteed. Only complete applications for work that improves safety, security, and weather efficiency will be considered. The information on this application is required to determine your eligibility and match your home with the appropriate assistance available.

- Once received, your application is added to our database to be considered for two levels of assistance:
1. **Volunteer-Led Repairs:** After a home assessment, you may be selected by a volunteer team to receive work focused on improving your home's safety, security, and weather efficiency during our Spring/Summer repair season.
 2. **Contractor-Led Repairs:** We also use the application database to identify candidates for external funding opportunities that require professional contractors for larger, more complex repair needs.

We do not perform decorating, remodeling, or emergency repairs under either level.

ELIGIBILITY & INSTRUCTIONS

NO GUARANTEE OF REPAIR: Applying does not guarantee your home will be selected for repair. **Due to the high volume, you will only be contacted if your application is selected for further eligibility review.**

1. **WHO QUALIFIES?** You must own and live in a single-family home and meet all three of the following requirements:
 - ✓ Be elderly (age 60 or over) OR certified as disabled (if under 60).
 - ✓ Qualify as low-income based on the table above.
 - ✓ Your home needs repairs for safety, security, or weather efficiency (we do not do decorating, remodeling, or emergency repairs).
2. **SUBMIT A COMPLETE APPLICATION:** (Do not send original documents. Make photocopies and keep your originals)
 - ✓ Fill out ALL information and complete each page of the application. Write "N/A" if something doesn't apply.
 - ✓ **Copy of Driver's License or Valid Photo ID.** Do not send expired identification.
 - ✓ **Verification of Permanent Disability** (If under 60 years of age): Provide a Disability Benefits Letter, doctor's note, or SSDI award letter.
 - ✓ **Verification of Current Household Income** for all residents over the age of 18: pay stubs, social security/pension statements, unemployment, etc.
 - ✓ If an adult has no income, contact our office at 502-371-4906 to request a Certification of Zero Income Form.

REPAIR AFFAIR WORK AGREEMENT

The person who owns and/or occupies the house is hereinafter referred to as the 'The Owner.' Therefore, this agreement is only between The Owner and Repair Affair and does not refer to any additional family that resides with The Owner.

If a Repair Affair team selects you, you hereby agree to and understand the following:

- ✓ Repair Affair is 100% completely volunteer-driven, and you are not guaranteed your home will be chosen; as such, all repair work is performed by volunteers. Volunteers and/or Repair Affair staff will conduct an onsite assessment if selected.
- ✓ If your home is chosen, Repair Affair agrees to facilitate the work as discussed and agreed to between The Owner and the team's leader. Volunteer teams focus on repairs that match their skill set, which may not align with your repair requests.
- ✓ The Owner understands that not all work may be completed due to time constraints. Volunteer groups may or may not be able or willing to return to your home to complete repair work. If any repair work is not completed by the volunteer team, the homeowner is then responsible for having the remaining repair work completed.
- ✓ On the scheduled work day, The Owner agrees to work with volunteers to ensure that no able-bodied adults loiter at the home.
- ✓ The Owner agrees to work with the volunteers (if physically able) for at least a 1/2 day.
- ✓ The Owner agrees to restrain all pet(s) by locking them in a room not scheduled for repairs or placing them outdoors in a confined area.
- ✓ The Owner takes full responsibility for any children residing at the home or visiting The Owner. For their safety, children will not be permitted access to areas where volunteers work.
